Welcome to your Financial Math course! I'm excited to spend the year with you and invite you to get in touch with any questions or concerns you might have.

This course teaches real-life application of math skills that will be needed after graduation. Concepts involving critical thinking and problem solving are taught through guided practice and application of math concepts in everyday living situations. Students will focus on improving their problem solving skills with the use of a calculator, including operations involving fractions and decimals, estimation and rounding, graphing, and measurement using the metric and U.S. customary systems. In addition to the financial math curriculum and projects, students will continue to work toward their individual IEP math goals.

### Class Expectations:

- **Be ON TIME to class.** This means inside the door by the end of the bell. You can't learn if you aren't here!

### **Grading:**

**40%** Assessments (including the final exam/project)

**30%** Participation in class assignments, notebooks and discussions

#### **Assessments**

There will be at least one formal assessment per unit. You are allowed one retake per test (unless other accommodations are required based on an IEP or 504). You can earn up to 100% on the retake.

There will be additional assessments based on individual IEP math goals. The results of these assessments will be used to track and report progress on skill development. They will be graded as credit/no credit and therefore cannot be re-taken.

#### Daily Classwork/Assignments

Students will receive daily assignments to practice skills learned in class. These assignments will be designed so that students can complete them during the class period. If students do not complete them during class, they should complete them as homework. No additional homework will be assigned.

#### **Class Projects**

Students will complete projects that allow them to use their skills for real-life applications. These projects will be differentiated for Financial Math and I will provide scaffolding as needed. Projects will help build skills in earning income, creating a budget, buying goods and services, saving and investing.
